<b>Association or Group</b>	<b>\$2,600 per election per candidate</b>
<b>Candidate or Political Committee</b>	<b>\$8,200 per election per candidate</b>
<b>Continuing Political Committee</b>	<b>\$8,200 per election per candidate</b>
- The contributor's employer, relatives or any third party may not reimburse contributions.
- Contribution check(s) from partnerships and LLC accounts must be signed by the contributing partner/member or be accompanied by a letter allocating the contribution to their individual partner/member. If the contribution(s) is (are) from more than one partner/member, all must sign a single letter detailing each individual's name and allocation amount.
